The annual fee for a retail permit is \$100.00 for each stand, if purchased before April 1 of the permit year. The fee for all delinquent permits is \$200 for each permit per stand. **Make cashier check or money orders payable to the Louisiana Office of State Fire Marshal.**

#### PERSONAL CHECKS ARE NOT ACCEPTED

Failure to comply with Louisiana Revised Statutes 51:650, et seq., and Louisiana Administrative Code 55:V:1905 may be cause for criminal and/or civil penalties and immediate closure of retail fireworks stand(s).

Permits are valid for retail sale only from noon June 16th to midnight, July 5th, and noon December 15th to midnight, January 1st of the permit year. However, no retailer permits will be issued during those dates.

#### APPLICANT CERTIFICATION
